

Personal Information Notice

Silvergate is committed to maintaining the privacy of your personal information. Consumer information that is collected and subject to the Gramm-Leach-Bliley Act or California Financial Information Privacy Act is exempt under the California Consumer Privacy Act (CCPA). Other temporary exemptions apply, such as information from business-purpose communications.

California job applicants, current and former employees, and contractors have the right to know before information is collected, the categories of personal information we collect, and the purpose. The following describes the personal information we collect and why.

Imagery of the iris, retina, fingerprint, face, hand, palm, vein patterns, and voice recordings, from which an identifier template, such as a faceprint, a minutiae template, or a voiceprint, can be extracted.
